Lamar Repowering Project Update

Superintendent Hourieh reported that on January 18, 2013 B&W finalized the deal with FS Elliott to purchase two 600 HP air compressors. The air compressors will be used to inject ammonia and for CO mixing in the boiler. Expected delivery is May 24, 2013. He also stated that the rear wall coal conveyors will be ready to ship by the end of the week.

Superintendent Hourieh reported that they have been reviewing several electrical and control drawings that were released recently by Louis Perry subcontractor to B&W and that they should be getting final construction drawings from B&W.

Superintendent Hourieh reported that ARPA and LUB are working together to refine the final construction cost that will include the air compressor installations and that negotiations are continuing with B&W.

ARPA board meeting is Thursday, January 31, 2013 in LaJunta.

System Operating Report

Superintendent Hourieh reported that they will continue their efforts in upgrading the 24.9 KV substation equipment. Some of the equipment that needs to be upgraded is the southeast circuit breaker. It was manufactured in the 1960's and we can no longer find replacement parts to maintain it. We are in the process of getting a quote for this budgeted item.

Superintendent Hourieh reported that the 2012 preliminary data of the three Lamar wind turbines showed that they have generated 13,252.8 MWH of electricity which is about 884.9 MWH more than 2011. He also stated that our crew has replaced a failed oil pump motor on the Springfield turbine. The rest of the turbines are running at a rate of 99% availability factor.

Superintendent Hourieh stated that he is working with representatives from Honeywell and Professional Meters Inc. in regards to the installation of Data Collecting Units (DCU) that will be used by the city to automatically read water meters. The DCU units will have to be mounted on our power poles and need to be supplied with AC power.

Leala Owen reported that they are accepting applications for the LUB/ARPA scholarship program. This scholarship is available to Lamar, McClave and Wiley High School seniors. This year's topic is "How does renewable energy impact the environment and what challenges would the electric utilities face in implementing renewable energy"? Deadline for turning applications in is April 19, 2013 and she will need volunteers from the Utility Board to review application.

System Operating Report

Superintendent Hourieh reported that sales of electricity through January are down approximately 9.46%. Residential sales were down approximately 3.9% and commercial/industrial down 13.7%, these two classes are approximately 95% of total sales for the month. Revenue is down 14.40% for this period which can be attributed to the removal of the ECA rate.

Superintendent Hourieh reminded the board members of last year's purchase of the faulty wind turbine generator brushes which caused premature failures to the slip rings in the wind turbines. After trying to settle with the manufacturer with no success it was turned over to our CIRSA attorneys. The manufacturer now wants to settle for a reasonable amount to resolve the claim. Superintendent Hourieh will keep the board updated on the status of the claim.

Superintendent Hourieh reported that the line crew is in the process of doing the annual transformer oil testing, this test will check for moisture content and dissolved gases in the transformer oil. This is a proactive approach to improve power reliability. All substations, plant, wind turbines and major power transformers will be checked.

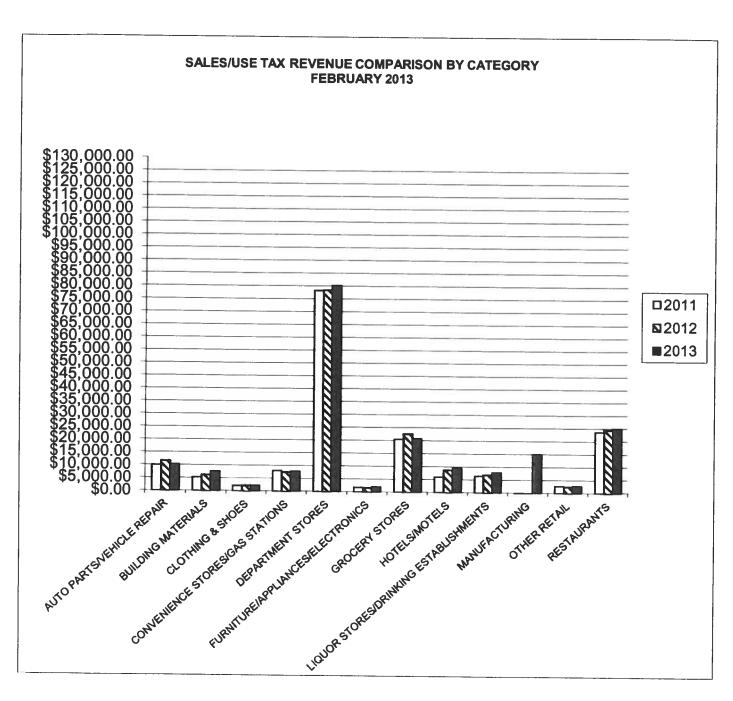

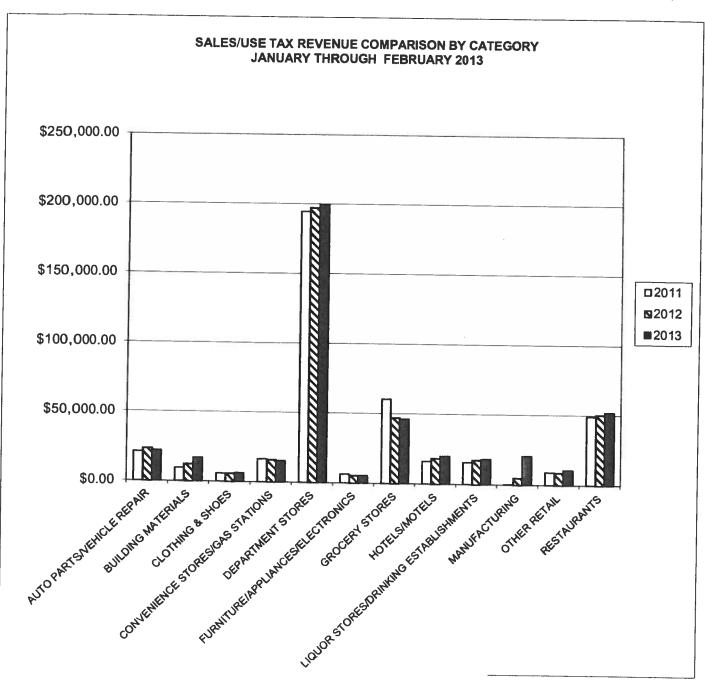

BACKGROUND:

In 2009, the City hired The Engineering Company, now know as Farnsworth Group, to design an odor control system that would alleviate the hydrogen sulfide odor complaints from the neighborhoods adjacent to the Prosperity Lane discharge points.

Farnsworth looked at several possible solutions, including chemical injection with a variety of chemicals and odor scrubbing at the point of discharge using one of several available technologies. In March of 2010, following Farnsworth's installation recommendation, it was approved by council to install a Syenco Pacemaker system. The Syneco system was leased for a three year period that will be ending in March 2013.

The lease amount for another three years is \$14,705.00, which includes replacement of any parts that might fail within the three years. It should be anticipated that the complete unit will be replaced every three years.

Purchase of the scrubber system would be \$14,915.00 and the media would have to be replaced every three years at a approximated cost of \$8,950.00. Also, if purchased, the City would stand the cost of any and all maintenance required by failure of any parts.

RECOMMENDATION:

Staff requests approval to lease the Syenco System for an additional three years.

After existing shelving is moved to increase shelving in other areas of the library, including storage areas, there will be some useable 20 year old solid wood shelving the library will be unable to use or store. The librarian from Canon City, Susan Ooton, has recently called me inquiring if there may be any shelving left over after the completion of my project. I am looking for the council's direction on how to answer her request.

RECOMMENDATION: Council to authorize transfer of used excess shelving to Canon City Library.

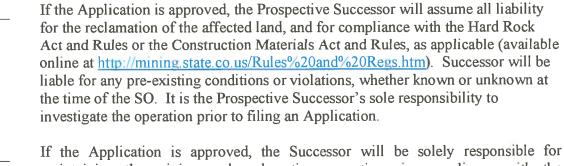

OBSERVATIONS

This was a normal monitoring inspection conducted by TC Wait of DRMS. The mine operator representative present was Mr. Tom Brubaker. Mr. John Sutherland and Mr. Rick Akers of the City of Lamar were also present during the inspection. The site is located in northern Lamar, east of Highway 50 on the Arkansas River. Post-mine land use for this site is wildlife habitat. The permit area is approximately 82.2 acres; 30.2 acres are ponds, and 10 acres in the south-central portion of the site is a concrete batch plant. The 10-acre batch plant parcel is being transferred out of the permit area and will be operated in the future by All-Rite Paving. The permit sign was in place and the permit boundaries are clearly marked.

The site is no longer being actively mined. Three ponds are present in the permit area south of the river. Over the past year, the operator has worked to clean up the debris that was present on the site, grade the site to final grading and in compliance with the flood plain plan. The site was seeded per the reclamation plan in February or March of 2012. Revegetation has not been successful, largely due to the dry growing season, and will need to be re-seeded. Some annual weeds and tamarisk are present on the site. Generally all earth work activities have been completed at this point.

No other problems were noted during the inspection.

It is the understanding of DRMS that the operator wishes to reduce the bond based on the reclamation progress. DRMS is in the process of re-evaluating the required bond for establishing desirable vegetation per the reclamation plan on file.

The initial seeding was not successful and will need to be re-seeded per the reclamation plan on file. Weed control should be implemented.

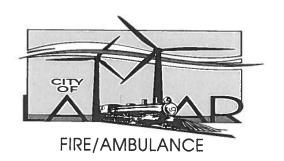

February, 2013 Activity Report for the Lamar Fire and Ambulance Services

Thanks to the efforts of Bob Ward and the kindness of Galen Burnett we were able to conduct valuable fire training in February. Galen owns the property on South 4th Street directly east of the City Complex. After all of the asbestos issues were addressed the Lamar Fire Department staff members were able to utilize the abandoned house for several fire training evolutions. Our typical Wednesday night training and a Saturday morning training was attended my most of our firefighters. Several interior fire attack evolutions were conducted prior to allowing the structure to completely be consumed by fire on Saturday afternoon. We follow the live burn standards of NFPA (National Fire Protection Association) 1403 including absolutely no use of any flammable liquids. All fires started within the structure were done with combustible solids such as hay, straw and cardboard. When flammable liquids are utilized the vapors released by the fuel are not controllable and can lead to violent explosions. As usual we were able to limit the fire to only the property we planned on destroying. Our fire and EMS crews spent over eleven hours that day training, cleaning and preparing our equipment for future incidents. I am very proud of all of our staff. I would also like to thank the Lamar Parks and Recreation staff for trimming back the trees to make the live burn even safer.

In other news.....

- Captain Burkhart conducted equipment check-offs for two of our staff members. Russell Ashton checked off on Engine 2 while Lynn McCoy checked off on the ambulances.
- 2. Lamar Fire & Ambulance staff members participated in the Lamar Community College Career Fair.
- Captain Burkhart began the process of getting our staff up to speed with required Fireworks
 Operators credentials which are needed for us to conduct our annual Independence Day
 fireworks show.
- 4. Captain Burkhart was required to issue a stop-work order on a fire suppression contractor whom was not licensed to conduct business in Lamar. After a brief pause the required documents were completed and the contractor was allowed to complete the job.
- 5. Deputy Chief Leonard conducted well sampling at the Holly and Granada landfills.
- 6. Our department covered for the Building Department two days in February.
- 7. Chief Cook met with Doug Harbour and others coordinating the 2013 9/11 Tribute Ceremony.
- 8. A technician from Physio-Control was in the station conducting annual service and inspections on our six Lifepak 12 cardiac monitor/defibrillators as well as our two Lucas CPR devices.
- Chief Cook, Chief McCrea and Administrator Sutherland met with several community groups in an effort to promote the community emergency response team concept. These groups



included the Ministerial Alliance, the Boy Scouts of America and our local 2nd Amendment group.

- Chief Cook, Captain Burkhart, Deputy Chief Leonard, Bob Ward and Chief McCrea met with Mr. Justin Lee of Prowers County Public Health in regard to a couple of public health issues.
- 11. Chief Cook met with a member of the Wiley Fire District board in order to set up monthly EMS trainings for members of the Wiley Fire Department Quick Response Team. These classes will be held once a month and will begin at the end of March.
- 12. Chief Cook Deputy Chief Leonard and Administrator Sutherland met with PMC Administrator Craig Loveless regarding access to pharmaceuticals for the ambulance service
- 13. Chief Cook and Captain Burkhart met with Karen Bryant and Leslie Day at PMC to address concerns involving the statewide 800 MHz digital radio system. We also discussed our willingness to provide education to select PMC staff members on the radio system as well as hazmat decontamination techniques.

As always, we certainly welcome any questions, comments or visits from the city council, media and the public in general. You are also welcome to observe our weekly training sessions. Our department trains the first and third Wednesdays each month starting at 7:00 p.m. The volunteer's business meeting is the second Wednesday evening each month at 7:00 p.m. Thank you for your time and please do not hesitate to contact me with any questions you may have.

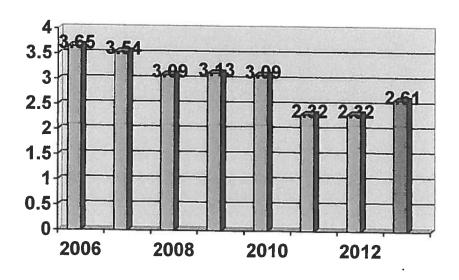

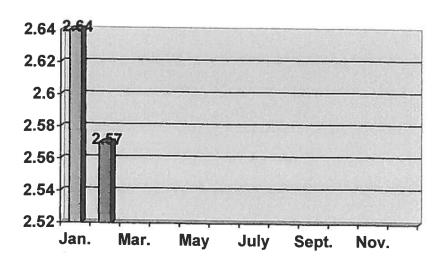

ACTIVITY REPORT

Technical service has been busy with our new email server. We are in the final stages of rolling out our enterprise level email service. We will be migrating to Exchange as our email solution. The final part of the migration is the cut over. We look for an ideal time as we will affect the City's entire email system.

Technical service is working on implementing a HA (high availability) solution for our SAN. We currently house most of our critical data on our SAN. We are in the process of migrating or mirroring our remaining services to our SAN. The new HA solution will allow for redundancy here at the City. We have a DR (disaster recovery) unit over at Light & Power that replicates every hour on the hour as well.

Technical service has had a few major hardware updates. Recently we switched our core network switching to HP. Our previous switches began to fail and random outages began to occur. We swapped over a weekend to minimize impact to our users. The old switches have been sent back to the manufacturer for repair as they have a lifetime warranty.

Our financial software company, ADG (American Data Group), is in the process of upgrading their software to a web based version. The new web based version is similar but different. The conversion is not as transitional as we had hoped and is taking longer than anticipated. We continue to train on the new system but we find errors and have to wait until they are fixed to proceed.

Technical service has begun replacing our wireless access points throughout the City. The new access points support new and enhance security features our old ones simply did not have. We have started in the Library and will continue with the Recreation Center and finally the complex.

Technical service continues to improve the City website. We have recently enabled RSS feeds to the City website as well as a mobile version. We are in the process of setting up our RSS feeds now.

Happy Bookers Book Club met in February and discussed the book; Night Circus by Erin Morgenstern.

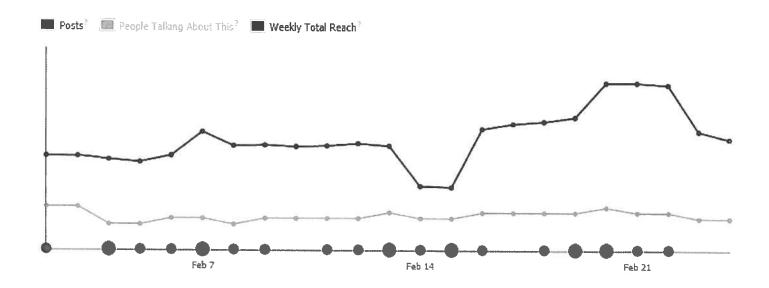

Police Department - Internal report

The police department has attempted to utilize the in-car computers to produce citations. Some technical issues have been identified and are being corrected by Tech Services.

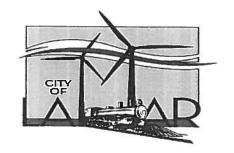

WATER RESOURCES

- 1) Honeywell Project is underway: We have acidified 4 wells and prepared another. The cleaning is working very well and flow tests are showing improvement.
- 2) Water Attorney, David Shohet, is continuing work on the City's water change case (05CW107-A and has been working to settle issues with objectors in the case
- 3) The 2013 Rule 14 Plan has been submitted to the state for approval.
- 4) The Substitute Water Supply Plan has been submitted to the state for approval.
- 5) A Pre-Application meeting with DOLA, CDPHE, CRWPDA, and Honeywell has been scheduled for March12th at 2:00pm for the Energy/ Mineral Impact and Drinking Water Revolving Fund programs. The deadline for the SRF is April 1st. The EM/I deadline is June 1st.

WATER

- 22.784 million gallons of water were treated in the month of January (a average daily demand of .842 MGD)
- 2) Repaired 5 water main breaks for January
- 3) Assisted Honeywell in data collection and performing field tests and other work needed for engineering
- 4) Preparing and planning for the older projects the department hasn't had a chance to finish, ("potholing" utilities, cleaning, grading, and finishing work)

WASTEWATER

- 1) 19.676 million gallons of wastewater was treated in February
- 2) Normal maintenance of collection system and lift stations
- 3) Install fencing at the sewer lagoons
- 4) Cleaned storm sewer drains
